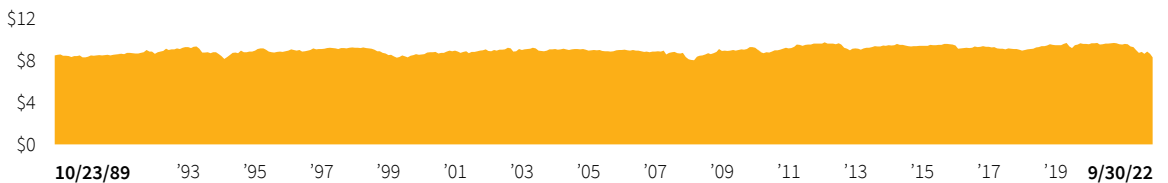
The fund invests 81.4% of its assets in investment-grade tax-exempt bonds.
