
The fund invests in short-term bonds and other securities, and generally maintains an effective duration, or interest-rate sensitivity, of three years or less.

The top 10% of products in each product category receive 5 stars, the next 22.5% receive 4 stars, the next 35% receive 1 star. The most recent 3-year period actually has the greatest impact because it is included in all three rating periods. Ratings do not take into account the effects of sales charges and loads. Putnam Short Duration Bond Fund received 4, 4, and 4 stars for the 3-, 5-, and 10-year periods among 534, 494, and 359 Short-Term Bond funds, respectively.
