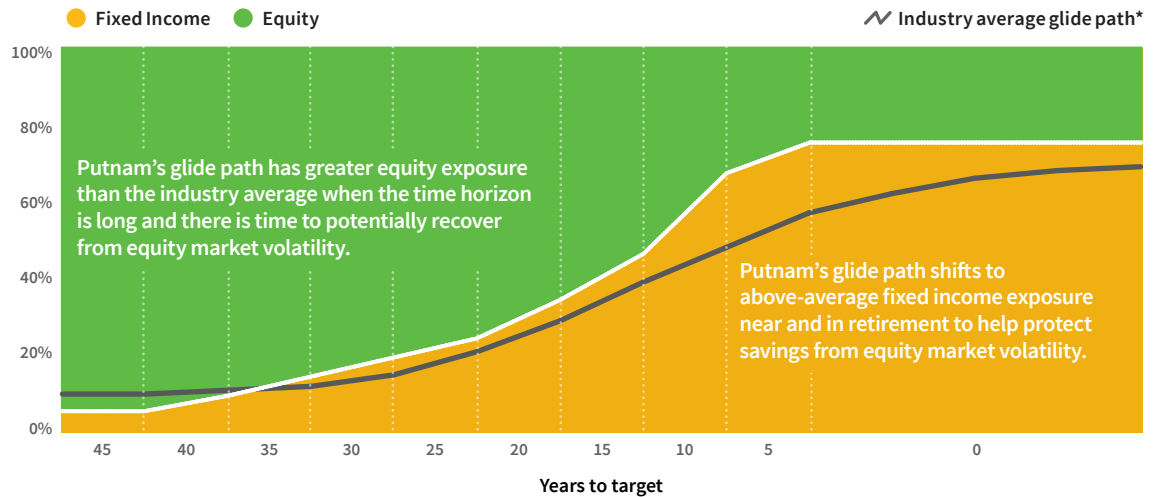

The dates range from 2025 to 2065 in five-year intervals.
