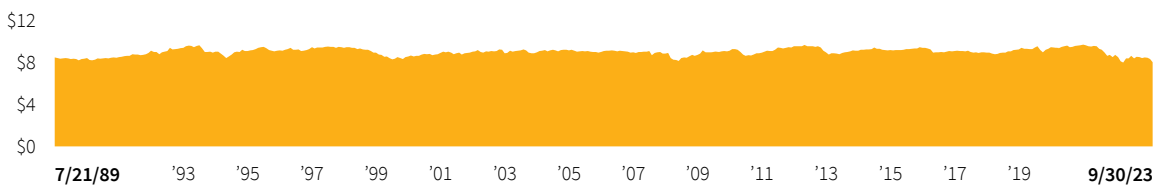
**A diversified portfolio**
