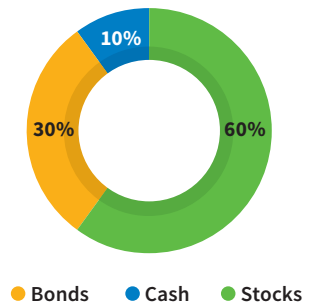
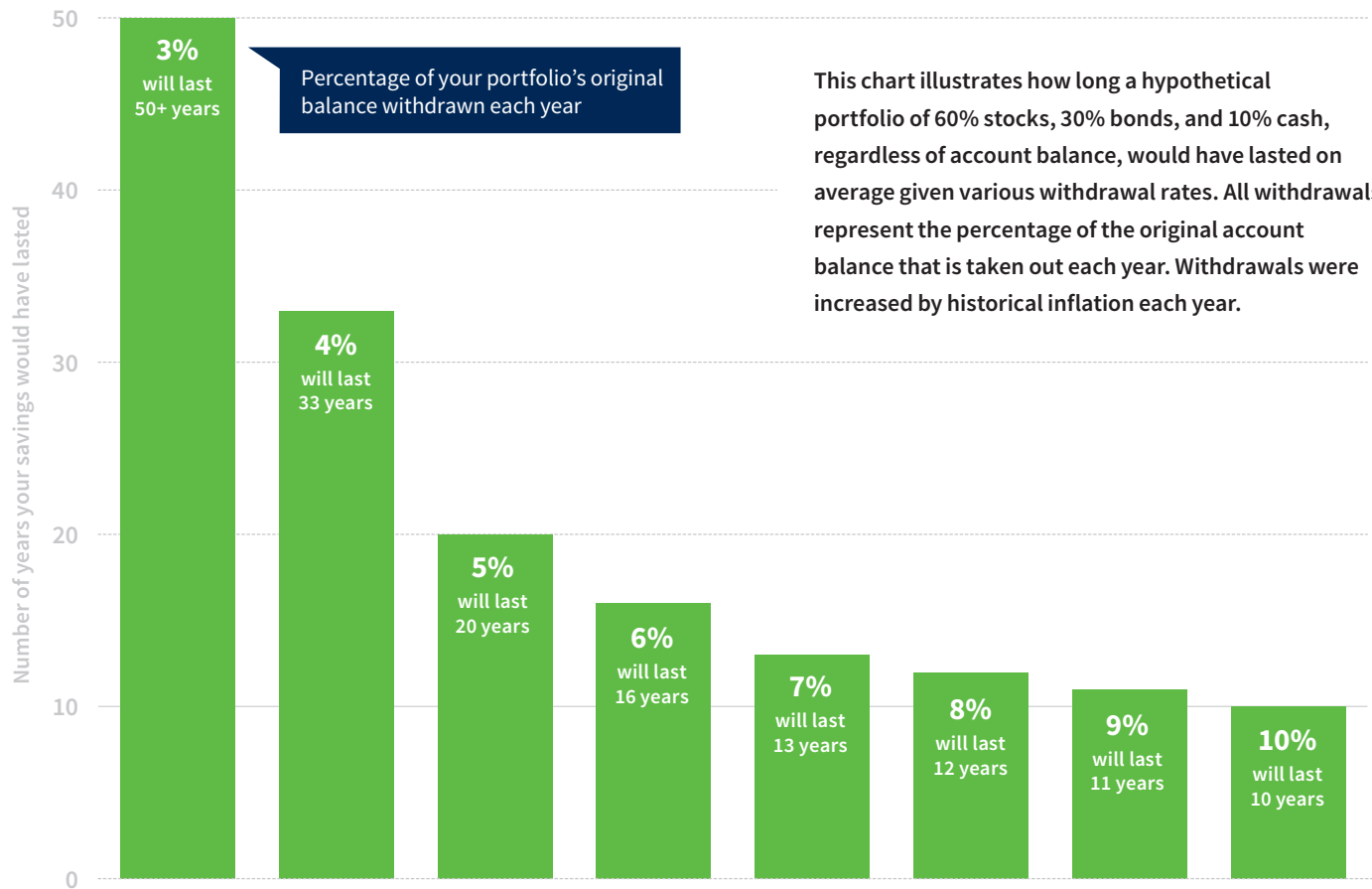


Withdrawing too much in retirement limits how long your savings last

The table below shows how various asset allocations affected a portfolio's expected longevity. It assumes that 5% of the original account balance was withdrawn each year and that withdrawals were increased by historical inflation each year.

Likelihood your portfolio would have lasted

● 90%–100%
 ● 60%–89%
 ● 0%–59%

Conservative	20% Stocks 50% Bonds 30% Cash	90%	37%	14%
Balanced	60% Stocks 30% Bonds 10% Cash	97%	79%	60%
Growth	80% Stocks 20% Bonds 0% Cash	96%	82%	72%
